Summary

1.1. This policy outlines the factual information about selection for the England National Kumite squad, who hold a current EKF Registration Slip. It also details the process by which the English Karate Federation (hereinafter EKF) will arrive at its decisions to select athletes for selection for major international events e.g. European, World, and Commonwealth Karate Championships.

Purpose

- 2.1. The objective of this policy is to ensure transparency for athletes and coaches and ensure that there is a fair and proportionate way for athletes to be selected for the national squad and for major international competitions.
- 2.2. By adopting a points based approach (see appendix A) this ensures the policy has been configured to ensure that the EKF selects the best karateka in membership of the EKF to represent the country, with the chances of medals maximised.

Scope

3.1. The scope of this policy includes any karateka in membership of the EKF wishing to select for the EKF National Squad. The policy will be used by the National Coaches to select various squads.

5. Eligibility criteria

- 5.1. In order to be considered for international competitions, the below are essential criteria that must be met:
 - Be an affiliated member through their respective Association/Club, and with no outstanding disciplinary issues, with the EKF and hold an in-date EKF Registration Slip.
 - British Passport holder
 - Aged 12 years or above
 - They have not whether by an act or an admission, brought the EKF into disrepute
 - Not currently serving a suspension for anti-doping violations (for more information on requirements and impact of breaches see the EKF Anti-Doping policy on the website)
 - Attend a minimum of 5 of the 10 national squad training sessions
 - Compete nationally and/or internationally accruing points as per the scoring system detailed in Appendix A
- 5.2. An Athlete must be on the current National Squad to be in contention to be picked to compete internationally for England. To gain a place on the National squad they must achieve a medal at one of the competitions on the list. They then will, with the permission of their Head of Association (HOA), receive an invitation to a trial. The trial will consist of 3 sessions in which, if successful, they will be asked to be part of the squad and if not, they will be given information on what to work on for next time. Once invited to the trial, their points will start to be added but will be removed if they are unsuccessful.

6. How to achieve points

- 6.1. Points can be gained from National and Regional Training sessions plus from competitions on the Championship List provided (see appendix A Selection Point Spreadsheet 'SPS'). These points will be added for a 12-month rolling calendar e.g. May 2022 points will be taken off in May 2023.
- 6.2. Points are only normally awarded if the athlete achieves first, second or third place. However, some competitions are deemed, due to difficulty or other factors to generate additional points, such as the European Championships, World Championships, KARATE 1 and other events.

7. Team selection dates and cut-off date for points

7.1. In order to allow for appropriate preparation and squad building the team will be selected 60 days before the championship start date. The athlete with the most points at that time will be selected and any further points gained before the championships will go towards the next selection. The coaches in conjunction with the Performance Director (Kumite) will set the minimum number of points required to be selected, this will be set at the start of each calendar year.

8. Process where athletes have the same number of points

8.1. If two or more athletes have the exact same number of points, the athlete with the best result at the last National Championships for their current category in which they are tied

will be selected. If athletes achieve the same result at the English/National Championships, then the best result at the British Championships will used and after that the best result at a WKF or international event.

9. Moving up age categories

9.1. When an athlete moves up an age category, they will transfer 50% of their points to their new category.

10. Athlete enters the wrong category

10.1. In the event an athlete enters the wrong/different category but wishes to stay in their original category, they will achieve 50% of the points for that event.

11. Under 21 and Senior Events

11.1. An athlete who enters a Senior category but NOT an U21 category will use any points achieved for their U21 and Senior selection points. If an athlete enters an U21 and Senior Category in the same Championships and the U21 result is better than the Senior result, then they will use the U21 points for their U21 selection ONLY and the senior result for their senior selection ONLY. If the Senior result is better than the U21 result, then the U21 points will be disregarded, and the Senior points will be used for both U21 and Senior selection.

12. U21 points that transfer to Senior Points only

12.1. The only points that will transfer from an athlete's U21 selection to Senior Selections re 50% of any European or World medal points achieved in the rolling 12-month period. No other U21 points will transfer over to their Senior selection points.

13. Exclusions and other key factors re: achieving points

- 13.1. No points will be achieved at domestic and international championships for getting through rounds this will be exclusively for WKF level championships (Youth League/Series A/Premier League).
- 13.2. Getting a bye is not rewarded as a fight won.
- 13.3. A partner being given kiken is rewarded as a fight won.
- 13.4. If an athlete wins a bronze medal without winning any fights, they will not receive the bronze medal points.
- 13.5. If an organisation merges categories, athletes will still get 100% of the podium points if they medal.

14. Transgender athlete selection

14.1. Any athlete who wishes to change their gender and compete in a different category to that which they were born must review the EKF Transgender and Transsexual Inclusion Policy which highlights all pertinent information required in order to select and compete in another gender category.

15. Appeals process

- 15.1. If there is an appeal concerning how many points an athlete has, in the first instance, the athlete or athlete representative e.g. parent/guardian, should contact the Head National Coach who will investigate this, and if there is an appeal or complaint about the selection process this needs to be done in writing to the Performance Department. If the athlete is not satisfied with this decision, then a formal appeal can be made to the Equality, Diversity and Inclusion Director (EDI).
- 15.2. The initial checks for an athlete's points will be carried out automatically through the EKF's computer programme. An independent check of the programme will be undertaken by the Performance Director for Kumite who will hear the first appeal.
- 15.3. No appeals will be permitted against the content of this published policy.
- 15.4. The grounds of appeal against a decision for selections can be founded on the inability to follow this policy or an error(s) of fact.
- 15.5. This Appeals process is provided on the limited grounds as set out in 15.1 the appeals process must not be an opportunity to dispute the opinion of the Selection Panel where they have followed the proper procedure. In reaching their decision, members of the Appeals Panel are acting as experts in their field. By agreeing to be bound by this Appeals process, athletes acknowledge and agree that the Appeals Panel will exercise independent judgment and discretion which they are not in themselves capable of challenging.
- 15.6. The Appeals Procedure is commenced when an athlete affected by a selection decision ("Appellant") makes an appeal in respect of such decision ("Appeal") by submission in writing in the form required by the Notice of Appeal (see below) to the EKF Equality, Diversity and Inclusion Director (EDI).
- 15.7. The Notice of Appeal must reach the EDI Director within 5 working days of the squad being selected. If the Appellant fails to submit the Notice of Appeal within this period, he or she will have lost their right of Appeal under this policy.
- 15.8. The Notice of Appeal must:
 - o Identify the specific decision being appealed.
 - Set out the ground(s) of the Appeal and the reason(s) why it would be substantially unfair not to alter the original decision; and
 - Set out a statement of facts upon which the Appeal is based, including full details of the basis of the appeal and the precise way the Appellant alleges that the Selection Policy has not been followed.
 - The Notice of Appeal should be as full as possible as it will form the basis of the remainder of the Appeal process under this Appeals Policy.
- 15.9. The Appeals Panel may, at its discretion, elect to receive evidence from such person(s) (including the Appellant) as it deems appropriate to, without limitation, verify facts as submitted in the Notice of Appeal. In such circumstances, the Appeals Panel will:

- Consider any representation(s) as to why such new evidence was not disclosed in the Notice of Appeal
- o If such new evidence is allowed in the Appeal, disclose it to the Appellant.
- 15.10. All EKF Appeals Panels will be formally minuted and a record stored securely for up to 3 years.
- 15.11. Due to the timescales involved, the EKF Appeals Panel will use any reasonable method of communicating with athletes which it considers appropriate and may include (without limitation) oral announcements to groups of athletes, telephone calls, text messages (WhatsApp) or email but always in keeping with good safeguarding practices. Athletes and their parents/guardians must review these communication channels to receive the selection decision and any subsequent communication relating to any related Appeal. Athletes should inform the EKF Appeals Panel of a preferred method of communications and provide relevant telephone numbers etc.
- 15.12. The Appeals Panel will be Chaired by the EDI Director. The Appeals Panel will include 2 other EKF Directors including the Performance Director and another EKF Director. Where a potential conflict of interest may arise an independent Chair will be appointed with another EKF Director nominated.
- 15.13. If athletes, or their representatives, wish to contest the EKF Appeals Panel decision then they have a legal right to challenge this via Sports Arbitration.

16. Confidentiality

16.1. All those involved in the selection process must keep confidential and not disclose any information regarding any aspect of the process (including any selection appeals process), the nominated athletes and the team selected, unless authorised by EKF Board of Directors. The Performance Department and the responsible EKF Director will work together to agree a media release and announcement of the team after ratification of the EKF Board.

17. Changes to policy

17.1. The EKF Board reserves the right to amend or vary this Selection Policy where necessary at any time. Any such amendments or variations will take effect from the first date of publication of the amended Selection Policy on the EKF website.
